The purpose of this solicitation is to seek qualified contractor(s) to PROVIDE ALL LABOR, MATERIALS, AND EQUIPMENT FOR THE ABANDONMENT THE WASTEWATER TREATMENT FACILITY IN CLARENDON COUNTY SC, PER SCDHEC REGULATIONS

You are encouraged to visit the sites provided. All work shall be performed in compliance with all local, state and federal mandates, including, but not limited to: SC Department of Health and Environmental Control, US Department of Labor, US Environmental Protection Agency and their delegated counterparts.

SECTION II: TERMS AND CONDITIONS:

COMPETITION: This solicitation is intended to promote competition. If any language, specifications, terms and conditions, or any combination thereof restricts or limits the requirements in this solicitation to a single source, it shall be the responsibility of the interested vendor to notify the Procurement Director in writing.

DEFAULT: In case of default by the contractor, the County reserves the right to purchase any or all items in default in the open market, charging the contractor with any excessive costs. Should such charge be assessed, no subsequent bids of the defaulting contractor will be considered until the assessed charge has been satisfied.

DISPUTES: The laws of South Carolina shall govern this Agreement. All litigation arising under said Agreement shall be litigated only in a nonjury hearing in the Circuit Court within the Third Judicial Circuit of Clarendon County, South Carolina. Upon approval of the Circuit Court, any such action shall be referred to the Master-in-Equity for Clarendon County. The prevailing party shall be entitled to recover attorney's fees and the costs of said litigation.

DRUG FREE WORK PLACE CERTIFICATION: By submitting an Offer, Contractor certifies that, if awarded a contract, Contractor will comply with all applicable provisions of The Drug-free Workplace Act, Title 44, Chapter 107 of the South Carolina Code of Laws, as amended

FINAL INSPECTION: Clarendon County Engineer will provide final inspection and SCDES will have a final close out inspection.

WORKING HOURS: All contractor(s) activity associated with this contract shall be performed during visible daylight hours only. However, Clarendon County, South Carolina may approve extended work hours if it is deemed necessary for the timely completion of work for this contract.

SECTION III: SPECIAL TERMS AND CONDITIONS:

CONTRACTOR REQUIREMENTS/QUALITY ASSURANCE

Workmanship shall be performed by skilled workman thoroughly trained in necessary crafts and completely familiar with specific requirements and methods specified herein. The Contractor will be asked to remove anyone from the work force who is observed performing unsatisfactory or unacceptable work, this includes subcontractors.

SITE LIABILITY AND HAZARDOUS MATERIAL CONTAINMENT: When necessary, warning signs or barriers shall be placed around the work site or at any property entrance(s) to control liability when performing demolition work.

- 1. Extreme diligence shall be taken to ensure that any surrounding vehicles, equipment, hardware, fixtures, materials, structures, and etc. are protected against damage.
- 2. Such damage shall be corrected at no expense to the owner.
- 3. All Federal, State and OSHA regulations must be strictly adhered to.

CONTRACTOR REQUIREMENT FOR RESPONSIVE SUBMITTALS

- 1. The Contractor shall submit references with their offer, please use the required verification sources on page 5 of this solicitation; you may use additional pages if needed. References will be checked.

PROVIDE ALL LABOR, MATERIALS, AND EQUIPMENT TO PERFORM ABANDONMENT OF

Work To Be Preformed

- Remove All Electrical Wiring, Control Panels and service poles
- Remove 3 concrete basins
- Remove 3 Baffles from the aeration lagoon (must be cleaned before going to landfill)
- Remove 4 surface aerator pumps (must be cleaned before going to landfill)
- Remove liner (must be cleaned before going to landfill)
- Remove the perimeter fencing once the lagoons are ready for backfill

ALL DEBRIS MUST BE TAKEN TO CLARENDON COUNTY LANDFILL @ 2475 JW Rhames Road. No Landfill Cost

- Pump the remaining effluent from the surface of both lagoons into receiving MH (location on map)
- Allow Solids to dry and cover with Caustic Lime
- After liner is remove mix solids with soil on the bottom of lagoon
- Cap the irrigation line next to road (location on map)
- Grassing and straw for soil stabilization

The sewage from the two lagoons will be pumped into the receiving Manhole going to the City of Manning. The sewage would be pumped from the surface of the lagoons leaving the solid on the bottom of the lagoon. At this time the solids will be allowed to dry, and a disinfectant will be applied to control odors and Vectors. Once the solids have dried, the liner will be removed and sent to the landfill. The 3 Baffles and 4 surface aerators will be removed, cleaned and sent to the landfill as well. The solids will be mixed with soil and left on the bottom of the lagoon. Fill dirt from the berms will be used for filling in the lagoons and extra soil, "If needed" will be brought in by the contractor to create a surface that is sloped and well drained. Grassing will be place over area for soil stabilization. Coordinate all work with Water and Sewer Dept. personnel.

All work shall be completed in accordance with SC CODE REGS. 61-82 Section 48-1-50- Proper Closeout of Wastewater Treatment Facilities
