ADDENDUM #1 -The purpose of this **ADDENDUM** is to clarify the language on the paragraph below and to modify/correct the bid schedule (Page 12) attached.

RESPONSIVENESS/ IMPROPER OFFERS: (a) Propose as Specified. Offers for supplies or services other than those specified will not be considered unless authorized by the Solicitation. (b) If this solicitation is a Request for Proposals, multiple offers may be submitted as one document, provided that you clearly Differentiate between each offer and you submit a separate cost proposal for each offer, if applicable (c) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. **Offers which impose conditions that modify material requirements of the Solicitation may be rejected.** If a fixed price is required, an Offer will be rejected if the total possible cost cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. Any deficiency resulting from a minor informality may be cured or waived at the sole discretion of the Procurement Director. (d) Price Reasonableness: Any offer may be rejected if the Procurement Director determines in writing that it is unreasonable as to price. (e) Unbalanced Bidding. Clarendon County may reject an Offer as nonresponsive if the prices are materially unbalanced between line items or subline items. An offer is materially unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated in relation to cost for other work, and if there is a reasonable doubt that the bid will result in the lowest overall cost to the County even though it may be the low evaluated bid, or if it is so unbalanced as to be tantamount. **Each item must be bid separately, and no attempt is to be made to tie any item or items to any other item or items. The County reserves the right to award the project by building and may delete/remove line items due to budgetary constraints.**

All other terms and conditions remain unchanged.
