ADDENDUM #2 -The purpose of this **ADDENDUM** is to provide answers to questions on Mulch and Sites.

QUESTION/ ANSWER

Q: Are you wanting us to put out mulch once or twice a year?

A: Once a year

Site 1 the Administration building

Q: There are areas that are overgrown by grass that had pine straw, is that to be removed and replaced with new pine straw?

A: Yes

Q: The center areas near the road, will we be allowing the grass to grow in those areas or laying pine straw?

A: Allow grass to grow in 3 center areas and lay pine straw around trees/shrubs.

Site 2 DSS/Coroner building

Q: Is there a walkable area around the inside of the pond?

A: Yes, the back side has grown up, but you can still walk around.

Site 4 Sheriff Office

Q: Will we be removing and replacing pine straw around the building and trees?

A: Yes, everywhere there is pine straw now, Sheriffs Side only. Fire Department does their side.

Site 6 Industrial Park

Q: Are the deep ditches on Rambay Rd my responsibility?

A: No

Q: Is the Fire Station property included in this bid?

A: No

Site 9 Health Dept

Q: There are 2 center areas in the parking lot, will those be my responsibility? They are not highlighted.

A: Yes, and the one at the main entrance off Boyce St.

Site 10 Judicial Building

Q: Look to already have fresh pine straw for this year, is there a way to verify are just replace with new?

A: Replace or freshen up as needed per the contract.

Site 11 Library

Q: Will we be clearing bushes off the back fence?

A: Keep trimmed back so there's no limbs hanging in the driveway.
